I agree to wave and relinquish any and all claims I may have as a result of participating in the program against the YWCA Pekin, any and all officers, agents, volunteers, employees, and any, and all other persons or entities, of whatever nature, that might be directly or indirectly liable for any injuries that I might sustain while participating in the programs.
